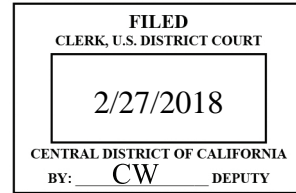

**DEFAULT JUDGMENT AND
INJUNCTION AGAINST ALL
DEFENDANTS**

1 The above-entitled matter came before the Honorable Michael W.
2 Fitzgerald, United States District Judge, presiding in Courtroom 5A of the above-
3 entitled Court, pursuant to Plaintiffs' Motion for Default Judgment. (Docket No.
4 31).

5 Defendants California Investment Immigration Fund, LLC ("CIIF");
6 Victoria Chan; Harris Law Group USA, LLC; Tat Chan; Zheng Chang; Fang Zeng;
7 and Harris Group III, LP, having been regularly served with process, having failed
8 to retain counsel and defend this action and its default against all Defendants
9 having been entered on December 12, 2017, and upon Plaintiffs having requested
10 judgment against the defaulted Defendants; and having considered Plaintiffs'
11 Motion and supporting papers, and good cause being shown, and pursuant to Rules
12 54(a), 55(b)(2), 58(a), and 65(d) of the Federal Rules of Civil Procedure,

13 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that judgment
14 be entered as follows:

15 1. Defendants shall be jointly and severally liable to Plaintiffs for a total of
16 **\$26,730,400**, which is inclusive of special damages in the amount of \$6,730,400
17 and punitive damages in the amount of \$20,000,000, distributed among the 15
18 Plaintiffs as follows:



- 20 a) To Plaintiff Mingan Chen, \$2,140,000, consisting of the sum of \$540,000
21 in special damages, and \$1,600,000 in general and punitive damages;
 - 22 b) To Plaintiff Yanmei Dai, \$2,140,000, consisting of the sum of \$540,000
23 in special damages, and \$1,600,000 in general and punitive damages;
 - 24 c) To Plaintiff Pengming Guan, \$2,140,000, consisting of the sum of
25 \$540,000 in special damages, and \$1,600,000 in general and punitive
26 damages;
 - 27 d) To Plaintiff Hong Jia, \$2,140,000, consisting of the sum of \$540,000 in
28 special damages, and \$1,600,000 in general and punitive damages;

- 1 e) To Plaintiff Hui Jiang, \$2,140,000, consisting of the sum of \$540,000 in
2 special damages, and \$1,600,000 in general and punitive damages;
- 3 f) To Plaintiff Yinshan Lan, \$2,140,000, consisting of the sum of \$540,000
4 in special damages, and \$1,600,000 in general and punitive damages;
- 5 g) To Plaintiff Zhiquan Pu, \$2,140,000, consisting of the sum of \$540,000
6 in special damages, and \$1,600,000 in general and punitive damages;
- 7 h) To Plaintiff Jue Wang \$2,140,000, consisting of the sum of \$540,000 in
8 special damages, and \$1,600,000 in general and punitive damages;
- 9 i) To Plaintiff Zi Wang, \$2,140,000, consisting of the sum of \$540,000 in
10 special damages, and \$1,600,000 in general and punitive damages;
- 11 j) To Plaintiff Jun Huang, \$2,140,000, consisting of the sum of \$540,000 in
12 special damages, and \$1,600,000 in general and punitive damages;
- 13 k) To Plaintiff Yanhong Chen, \$2,140,000, consisting of the sum of
14 \$540,000 in special damages, and \$1,600,000 in general and punitive
15 damages;
- 16 l) To Plaintiff Wei Yang, the sum of \$246,800 and \$700,000 in general and
17 punitive damages;
- 18 m) To Plaintiff Yi Zhang, the sum of \$246,800 and \$700,000 in general and
19 punitive damages;
- 20 n) To Plaintiff Changding Zhao, the sum of \$246,800 and \$700,000 in
21 general and punitive damages; and
- 22 o) To Plaintiff Li Ge, the sum of \$50,000 and \$300,000 in general and
